3. Interested parties can see material during working hours in the respective department/offices.
4. Successful bidder will have to deposit 25% of the offered amount in cash immediately after finalizing the bid.
5. In case bidder does not turn up within 10 days from the date of finalization of bid to take the delivery, an amount @ 2% of the auction value per day shall be charged as ground rent for next 15 days and after than the deposited amount shall be forfeited in favor of AMU.
6. The auction committee reserves the right to accept or reject any or all offers or postponed the auction without assigning any reason.
7. all the cases of dispute will be subject to Aligarh District Court Jurisdiction.
8. Other terms and condition if any shall be announced at the time of the opening of quotation.
9. Quotation shall be opened in the presence of the bidders or their representative who submitted the quotations and members of the auction committee in the respective departments on schedule date and time.
